Say good-bye to the extra costs and inconveniences associated with getting your monthly loan payments to us on time. Now you can be assured of timely payment by enrolling in **Direct Pay**.

Convenient!

With **Direct Pay** you authorize an automatic transfer from your US Dollar Account for your loan payment. (The account must be at a financial institution that clears funds through the United States Federal Reserve System.)

Your payment is made even when you're on vacation with us!

Very Economical!

You do not have to worry about bank fees, courier or mail fees.

Absolutely Reliable!

Each payment appears on your bank statement so you know exactly what has been paid and when. You will receive notification in advance if any change will occur in the amount charged (i.e., when or if escrowed maintenance fees and taxes are adjusted).

You may cancel your enrollment in **Direct Pay** at any time by calling Financial Services at 800-845-4226 or 801-828-1046.

There are no extra charges. This service is absolutely free.

How to Enroll:

It's easy. Just complete the authorization form below and send it **along with a voided check**. If you have more than one loan to enroll in **Direct Pay**, please include all loan numbers on the authorization form. We will confirm receipt of your authorization and notify you of the date your first payment will be deducted. **(As my account must be current to be enrolled in this monthly program, I hereby also authorize MVCI to debit my amount that is past due.)**

If your debit is declined by your financial institution, and your account is over 89 days past due, you will automatically be suspended from Direct Pay, and you will be required to mail your payments to MVCI.

I understand that MVCI shall not be liable for any errors caused by my financial institution in connection with Direct Pay.
